Rotary Model United Nations Permission Slip

Authorization and Release

I am the parent/guardian of the student listed above, and hereby authorize and consent for my child to participate in the Rotary Model UN event described above. I agree not to hold the Rotary Model United Nations Committee, any sponsoring Rotary Club or its members, or Rotary District 5110 liable for any expense or injuries that my student may incur or cause while attending this event. I understand that my student is responsible for his/her own behavior at all times. If my student becomes involved in any behavior which presents a danger to his/herself and/or others or is considered seriously inappropriate (e.g. general harassment, leaving the site of the event, sexual harassment, sexual misconduct, use of drugs or alcohol, use of tobacco, or participation in any illegal activities), one or more of the following steps may be taken: exclusion from participation in event activities, phone call to parent or legal guardian, and/or expulsion from the event. I understand that if my student causes damages at the site of the event, I will be charged for such damages. If my student is asked to leave an event that I will be responsible for transportation charges incurred with early dismissal. I understand that I will be kept abreast of my student activities and behavior and will be aware of the situation before any action is taken. However, I realize that the Rotary Model UN Committee will make the final decision in any action that involves my student irrespective of my opinion. I understand that the Model UN Committee reserves the right to handle the situation in any way that it deems appropriate and that will have the most positive result for the student and for the entire group.

I further authorize the Rotary Model UN Committee and/or Rotary District 5110 to obtain medical care, including hospital care if necessary, for my child while he/she is participating in the Rotary Model UN event and give permission to the physician(s) selected by the Model UN Committee and/or Rotary District 5110 to professionally treat and hospitalize, if necessary, my child. In consideration of Rotary sponsorship of the Model UN event, I hereby assume the risk associated with my child's participation in the Model UN event and irrevocably agree to release, indemnify and hold harmless Rotary, the Rotary Model UN Committee representatives, successor and assigns from any and all liabilities, damages, claims, losses, lawsuits, expenses (including without limitation reasonable attorney's fees and costs), or demands of any kind and nature whatsoever, whether or not a lawsuit or other proceeding is filed, that may arise out of or relate to my child's actions or participation in any activities related to the Model UN event. This authorization shall serve as a full and complete general release and assumption of risk for my child, for his/her heirs, estate, administrator and assignees, and for all member of my family.

During the Conference, and for all training sessions leading up to the Conference, I give permission for my child to be transported in a bus, car or van to and from these sessions by his/her advisor, and other advisors and supervisors affiliated with the Model UN Conference.

I give permission for my child's name and likeness to be used in present and future Rotary Model United Nations publications and activities.
