I understand that my Student is responsible for his/her/their own behavior at all times. If my Student becomes involved in any behavior which presents a danger to him-/her-/theirselves and/or others or behavior considered seriously inappropriate or in violation of the MUN Code of Conduct supplied to the Student, including but not limited to general harassment; leaving the premises of the MUN conference without their advisor's or MUN Director's permission; sexual harassment; sexual misconduct; use of drugs; alcohol or tobacco (including vaping); or participation in any illegal activities, one or more of the following actions may be taken: Exclusion from further participation in MUN activities; expulsion from the event and premises; and/or a phone call to the parent or guardian. I understand that if my Student causes damages at the site of the MUN conference, I will be responsible to pay for such damages. If my Student is asked to leave the MUN early or is expelled, I will be responsible for their transportation home.
